Polk County has adopted rules forbidding the sale, storage, and manufacture of beer and like beverages within 2000 feet (or some lesser distance) of schools, churches, and other places of public gathering or within 300 feet of a residential dwelling if the owner of the dwelling objects to the issuance of a beer permit.

I certify that I am knowledgeable of the laws prohibiting the sale of beer to minors and that this application contains true information to the best of my knowledge and belief. I am also aware that the entity shall not be issued a permit or it's permit shall be revoked if my business location causes traffic congestion or interferes with schools, churches, or other places of public gathering, or otherwise interferes with public health, safety, or morals.

Notice: A non-refundable \$250 fee must accompany this application. If the application is approved, you are required to provide documentation of sales tax registration to the county within ten days of approval. Any applicant making any false statement in this application shall forfeit his permit and shall not be eligible to receive any permit for a period of ten years.

A privilege tax of \$100 is imposed on the business of selling, distributing, storing, or manufacturing beer in this state effective January 1, 1994 and each successive Jan. 1. Any holder of a beer permit issued after January 1, 1994 shall pay a prorated portion of this annual tax when the permit is issued.
